ADDITIONAL BUSINESS

Revenue Committee

Chris discussed the need to seek additional sources of income to offset the softness in advertising revenue that we're encountering with the directory. There have been efforts in the past but none have been pursued to date. Several alternatives were suggested:

- Promote the golf tournament and incorporate a raffle for a car or an LSV, which would be donated by a dealer in Charleston. The raffle could also be promoted at other events.
 - The challenge to promoting the tournament may be timing, the tournament is in October and there are a lot of different events going on at that time.
 - o The club needs to put out a 'save the date' to the community to promote the tournament.
- Other organizations have raised large sums with a shooting contest
- There were additional suggestions including:
 - Wine tasting and auction
 - o Raffle a villa in Tuscany, or a condo in Charleston
 - Conduct an oyster roast

Revenue generation will become an ongoing activity for the Club.

Website enhancement

Chris suggested that the Club review the website and revise/update it to be more useful to Clubmembers and other community members. He suggested that directory advertisers should be promoted on the website, and Teri Lash can assist with this. A Clubmember, Brian Boling has volunteered to do a review of the website and provide a recommendation on how to improve it.

It was suggested that we should find a way to work with the organization, and it was also suggested that Brian be asked to speak at a club meeting and also, to join the club. In a subsequent conversation. Ray Hoover and Thad Peterson agreed to set up a meeting with Brian to continue the conversation.
